Additional information to be collected on Annual Validation for LPs – June/July 2021



The Limited Partnerships (Annual Validation) Regulations, 2020 require additional information to be submitted at annual validation.

The additional information will only need to be collected once per year, at annual validation. There is no requirement for this additional information to be updated as and when changes occur.

The following table shows how the additional questions will be laid out on the online LP annual validation form.

Please note that not every LP will need to answer every question.

Fields are automatically shown/hidden on the online form depending on whether they are mandatory; details on the criteria to show/hide each field are in the 'Mandatory' column below. The 'No.' column is to make the table easier to follow and is not be included on the online form.
