GUIDANCE

Under section 18(1) of the Charities etc. (Guernsey and Alderney) Ordinance, 2021 a registered organisation must inform the Registrar as soon as reasonably possible of any payments it makes to any party outside the Bailiwick of Guernsey that meet or exceed the specified amount.

This does not apply to payments that -

- (a) are made to an organisation in the United Kingdom, Jersey or the Isle of Man to which the relevant organisation is affiliated, or
- (b) comprise expenditure incidental to the activities of the registered organisation.

The specified amount, set by regulation, is £100,000.

Registered organisation details
