The process for LLP, foundation and LP annual validations/renewals remains the same as in previous years - this update contains more information and there is comprehensive guidance available on our website to help you through the process.

Over the last few months the Registry has been meeting with representatives from corporate services providers, industry groups and other stakeholders to give an update on the Registry's work, listen to feedback and also to help shape the Registry's values, vision, mission and objectives going forward.

I would like to take the opportunity to thank all those that attended the sessions for their valuable contributions.

Also included in this update is an overview of the Registry's activity so far in 2019.

# Overview of Registry activity so far in 2019

## Company annual validations

January and February are dominated by the company annual validation process, with 75% of submissions received during those two months being annual validations.

The company annual validation filing compliance rate was 96.73% - 584 companies in total were listed for strike off for failure to file their annual validation this year. 313 (53.6%) of the companies listed for strike off were subsequently removed from the strike off list as they filed their annual validations before the 20 May strike off date.

## **Incorporations and migrations**

Annual validations are the Registry's main focus during the first few months of the year but we also continue to work on our other 'business as usual' activities.

Of particular note is the number of migrations into Guernsey from other jurisdictions so far in 2019. Between 1 January and 31 May 2019, 53 companies have migrated in. This represents a 39.5% increase over the same period last year.

Company incorporations also remain strong with 487 companies incorporated between 1 January and 31 May 2019. 49 of those companies took advantage of the Registry's fast track (2-hour or 15-minute) incorporation service.

The LP register continues to grow with 93 LPs registered so far this year. There are now 2108 LPs registered. LLPs are also showing a positive trend, with 10 new registrations to date in 2019, meaning the total register size has grown by just under 9%, (to a total of 113) in the first 5 months of the year.

# Other Registry activity

The Registry has been working with its stakeholders to help shape its values, vision, mission, strategy and objectives through a series of workshops. Work on this is nearly complete and we will be publishing the results of this exercise shortly.

We have also continued to engage with other Registries internationally through our membership of the European Business Registers Association (EBRA) and the Corporate Registers Forum (CRF). The Registry attended the CRF Annual Conference which provided valuable insight into the issues affecting registries globally, and will also be attending the EBRA Conference in June.

Maintenance and investment into our systems is continuing in order to ensure the continued reliability and ease of use of our services. This includes updating the platform that the database and online system currently use to a new version. There may be some system downtime needed to do this but we will notify all CSPs and Regulated Presenters by email as soon as we know the likely dates and times for this.

## LP, LLP and Foundation Annual Validation/Renewal

## Limited Partnership annual validation

The Limited Partnerships (Fees, Annual Validations and Miscellaneous Provisions) Regulations, 2016 requires all LPs (registered before 1 May in the current year) to file an annual validation by the end of June.

The 2019 LP annual validation process is unchanged from last year, and there is no change to the annual validation filing fee (£500).

LP, LLP and foundation annual validation/ renewal deadline:

30 June 2019

All limited partnership annual validation submissions are now filed online at <a href="www.greg.gg">www.greg.gg</a>. Guidance on how to file the submission is available to view here: <a href="www.guernseyregistry.com/LPAV">www.guernseyregistry.com/LPAV</a>.

All limited partnership annual validations received after 30 June will be subject to a £100 per month late filing fee.

## Limited liability partnership annual validation

The Limited Liability Partnerships (Guernsey) Law, 2013 requires all LLPs (registered before 1 May in the current year) to file an annual validation by the end of June.

Paper copies of the annual validation forms have been sent to the registered office of each LLP. The forms are pre-populated with the current information held on the register.

A member of the LLP (authorised to make the necessary declaration) will need to check that the information is accurate and sign and date the form.

The form must then be returned to the Registry (by post or email to <a href="mailto:enquiries@guernseyregistry.com">enquiries@guernseyregistry.com</a>) by 30 June, along with the filing fee of £500 (paid by cheque, Registry account or credit/debit card).

All LLP annual validations received after 30 June will be subject to a £100 per month late filing fee.

#### Foundation annual renewal

The Foundations (Annual Renewal) (Guernsey) Regulations, 2014 require all foundations (registered before 1 May in the current year) to file an annual renewal by the end of June.

Paper copies of the annual renewal forms have been sent to the registered office of each foundation. The forms are pre-populated with the current information held on the register.

A councillor or resident agent of the foundation will need to check that the information is accurate, confirm whether there have been any amendments to the Charter since incorporation/last renewal and sign and date the form.

The form must then be returned to the Registry (by post or email to <u>enquiries@guernseyregistry.com</u>) by 30 June, along with the filing fee of £500 (paid by cheque, Registry account or credit/debit card).

All foundation annual renewals received after 30 June will be subject to a £100 per month late filing fee.




### My Registry Relationships functionality

The Online Services Portal allows directors to view their personal information, including the residential address currently on record, and the directorships and resident agent relationships they hold.

These records can also be exported as an Excel file by selecting 'Export'.

The 'My Registry Relationships' functionality can be accessed by logging into the website at www.greg.gg then selecting 'My Profile'. You will need to enter your person ID number (6 digit) and person PIN (4 digit) then click 'Verify Detail' to access the system.



### Bulk change of registered office address

The Registry accepts requests from CSPs who are moving registered office, to change the registered office address details of companies that they administer.

This is intended to save CSPs time; where the Registry does a bulk change, the CSP only needs to complete the <u>bulk change of address form available here</u> and return it to the Registry by email. We will then change the addresses on your behalf.

Note: Bulk change of addresses can be filed where over 25 companies are changing address. We are unable to accept bulk changes of address for limited partnerships, limited liability partnerships or foundations - these changes should be submitted individually using the normal process.

## Reports and data extracts

On request from CSPs we can provide extracts of data held by the Registry relating to companies they administer. This may be useful to help CSPs with their own internal data integrity checks, and also in the run up to annual validations.

Some examples of reports and extracts we can provide include:

- Details of all entities registered at your registered office
- Details of all entities where your CSP is the resident agent
- Details of entities that have/have not yet filed annual validations
